



N4safe Report #21 ACTION UPDATE & REMINDER

Thank you to the dozens of supporters who sent one-click emails to the mayor. But more have to be received to have an impact. Please send your email today.

Despite the city's overtures at public meetings in December '23 that "**things will be different**" and the "**mayor's office will take charge**" of the management and operation of the NW Naito homeless facility, there are daily public safety and security breeches and countless violations. (Please note the attached photos indicating just how serious the problem is)

Seven months ago, the Mayor's office and Prosper Portland **surreptitiously changed the NW Naito homeless facility lease to a "permit"** (along with language in the Pearl District Urban Renewal Plan) **to bypass the fact the lease called for a unalterable expiration date of 12/31/23** along with its relocation. Since then, no real or lasting improvements have been made, finger pointing continues, and the city has summarily shut down any attempts at communication with n4safe volunteers. -continued below-

There have been no meaningful responses to a multitude of letters (outlining the ongoing and specific violations with photos) from the mayor, commissioners, or any of the city run orgs like Prosper Portland. In Addition, there is not a new GNA, and certainly not one shared with or approved by the greater community.

As you may know the Chair of the Pearl District Neighborhood Association publicly denounced continuation of HOH unless there was a legally binding GNA. He and the PDNA were working on the 'new' GNA that will not be a legally binding document. This is at best, perplexing and at worst, a disturbing turnabout. **As of March of 2025 there is NOT a new GNA promised by the Mayor's office to be inn place 6 weeks after Prosper Portland approved the "land use permit" in December of 2023.**

Meanwhile, many of the neighbors are paying for additional private security while neither the city or the NW Naito homeless facility, **has put in place safety and security measures required in the existing GNA - nor have there been any in response to numerous illegal activities on and around the city run center on the property.**

As you can see, the neighborhood, residents and businesses continue to suffer from the city's malfeasance.

n4safe volunteers are working daily to ensure the city is held accountable to the same laws as every other citizen.

Updates: January and March 2025 - Letters continue to the Mayor, Council and the County reporting permit and GNA violations at the facility (see attached)

June/2024 - Two n4safe volunteers filed an action with the Oregon Court of Appeals to overturn the LUBA dismissal. DENIED by the Court 9/2024

January/2024 - Three n4safe volunteers filed an action with the Oregon Circuit Court to declare the declaring the use of the property is in violation of the city plans.

April/2024 - DEQ permits the city to continue operating the facility on contaminated land for another 5 years, despite writing in their decision: *"Decisions regarding site permitting and use reside outside of DEQ's regulatory authority" AND,*
*"We agree that capping beyond 5 years **begins to push** the definition of "temporary".*
